Inspection report regarding the grant of Extension in provisional affiliation for the existing course(s) upto the session 2023-24, Ex-post facto extension in provisional affiliation for 2nd and 3rd year of B.A. With earlier Existing Intake of 160 seats and its continuation of 1st year and for/from the 2019-20 & 2021-22, Ex-post facto extension in provisional affiliation for 2nd year and 3rd Year B.com with earlier exiting intake of 80 Seats and its continuation of 1st Year and for/from the 2019-20 & 2021-22. In the Govt. College for Girls ,Unhani Distt. Mahendergarh w.e.f. session 2023-24.

With reference to letter no. IGU/CB/2023/9695, dated 11.12.2023 regarding the above cited subject. In this regard the committee (Dr. Aditi Sharma, Dept. of Commerce, IGU, Meerpur, Dr.jyoti Yadav, Department of English, Govt.College for Women Pali ,and Dr. Rashtar Pal Department of Maths, Govt.College Chhilro visit the said college on 18.01.2024 for grant of the following:-

1. Continuation in provisional affiliation for the existing course(s) upto the session 2023-24 to whom the provisional affiliation has already been granted by this university.
2. Ex-post facto extension in provisional affiliation for 2nd and 3rd year of B.A. With earlier Existing Intake of 160 seats and its continuation of 1st year and for/from the 2019-20 & 2020-21, respectively.
3. Ex-post facto extension in provisional affiliation for 2nd year and 3rd Year B.com with earlier exiting intake of 80 Seats and its continuation of 1st Year and for/from the 2019-20 & 2020-21. respectively.

Observations :-

- i) The college has sufficient space for classrooms, library, playgrounds, labs, etc for the above mentioned courses. Sufficient building (lecture rooms) is available for running the above said courses.
- ii) The college has labs , sports Room that requires strengthening for equipment's, apparatus etc.
- iii) The college has tutorial room , Multi purpose hall ,Language Lab, Smart Class Room sports ground ,Gymnasium and Canteen also.

- IV) The College has eligible teaching faculty for the above said courses.
- V) A book bank has also available/run in the library for the needy students .

Deficiencies:-

- I) The committee recommends to purchase some more, Books/e-books, Magazines and journals/re-journals for strengthening the library.
- II) The Committee recommends for the availability of permanently posted teaching and non- teaching staff as per the workload for the smooth functioning of the College.
- III) The committee recommends to purchase more computers for the said courses .

Keeping in view of the facts, the committee recommends that provisional affiliation may be granted for the above said courses points Sr.No. 1 to 3 subject to the fulfillment of the above deficiencies within three months.

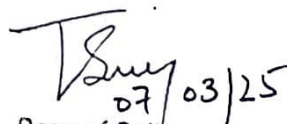
